## General Terms and Conditions for the Tenderer

1. The firm will submit tenders on the prescribed format duly affixed with seal and signature of the firm and should be put in one main envelope failing which the tender will be rejected. The tender must be superscribed as  
**"TENDER FOR THE SUPPLY OF ..... (Item Name)**
2. Tender document can be purchased from the Office of the Block Medical officer Kulgam w.e.f 05.11.2011 during working hours on working days from 10 AM to 4 PM. Bidders can obtain any further information from Block Medical officer Kulgam. Bidding documents can also be downloaded from the website [www.rashiddar.net](http://www.rashiddar.net) .
3. Bids must be accompanied by security of ₹. 1,000/- as Earnest Money (Rupees one Thousands only) as DD in favour of "**Block Medical Officer Kulgam** valid for six months and payable at Kulgam, only Demand Draft is acceptable which will be put in a separate envelope failing which the tender will not be considered.
4. In case, the date of opening of tender a holiday is declared by the Government, the same will be opened on the next working day at the same time & venue.
5. Any tender which is not on the proper tender form, will not be considered.
6. Tender received after 2. PM on the due date will not be entertained.
7. All disputes will be settled within the jurisdiction of the Head quarter of the Medical Block Kulgam.
8. The Block Medical Officer Kulgam has no binding to accept the lowest tender and reserve the right to reject any or all tenders without assigning any reason, reserve the right to amend the terms and conditions of the contract.
9. In the event of the tenders being submitted by a firm, it must be signed separately by each member thereof or in the event of the absence of any partner, it must be signed on his behalf by a person holding a power of attorney authorizing him to do so or in the case a company, the quotations should be executed in the manner laid down in the said company's Articles of Association/Memorandum of Articles.
10. All the columns of the tender form shall be duly and exhaustively filled. The rates & units mentioned should not be over written and tender with cuttings and over writings in rates and units will be rejected. Rates should always be mentioned both in figures and words.
11. The bidder should put his initial on all the corrections, cuttings and over writings other than in rates and units.

12. No tender will be considered unless and until all the documents are properly signed on each page by the authorized signatory of the firm.
13. In the event of tender being accepted, it will be converted in to a rate contract for 90 days which will be governed by the terms and conditions of the tender form
14. The tenderer should certify in an unequivocal terms that the item offered are strictly as per N.I.T specifications laid down by this office.
15. Tenders/offers of the firms which do not conform to the NIT specifications/rules, terms and conditions will be ignored and rejected.
16. Minimum delivery period must be quoted clearly on a separate sheet in the offer.
17. The successful bidder shall within 15 days of the issuance of the supply order required to deposit a Performance Security equivalent of 5% of the order in the shape of Bank Draft in favour of " **Block Medical Officer Kulgam** "payable at Kulgam placed by the tenderer as the performance security. The Performance Security shall be denominated in Indian Rupees only. This performance security shall be refunded after the satisfactory completion of one year of warranty / guarantee period wherever applicable. The performance security amount will not carry any interest.
18. The payment will be made only after satisfactorily receipt and installation of the material at the concerned institutions in the **Medical Block Kulgam**.
19. The ordered item shall be supplied in adequate packaging to prevent damage or deterioration during transit to the final destination. The packing shall be sufficient to withstand, without limitation, rough handling during transit and exposure to extreme temperature and open storage.
